Awards 1st - 6th.

All horses on the grounds must show proof of current negative Coggins, original plus a copy to leave at the show grounds.

Stallion must be handled by person 19 or older.

All persons on said grounds are considered participants subject to WI Liability Law which states: A person who is engaged for compensation in the rental of equine equipment or tack or in the instruction of a person in the riding or driving of an equine or being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in Section 895.481 (1).
