What is the WSHCEF?

Wisconsin State Horse Council Equine Foundation

The WSHCEF is a tax exempt, non-profit 501(c)(3) organization. The Wisconsin Horse Council established this charitable fund arm of the WHC in 2002 to allow people the opportunity to support equine projects by giving tax deductible contributions to the WSHCEF.

Our purpose is to encourage a broad range of equestrian interests by providing financial support for:

Large animals can be unpredictable, especially when they are in desperate life or death situations. Horses when stressed and trapped can injure themselves and cause significant damage to property. Whether an animal is involved in a trailer accident, submerged in mud or water, has fallen into a ravine, cast in a stall, or has fallen on barnyard ice and cannot get up, it is human nature to want to help. These are dangerous circumstances. Further injury to the animal and injury to the person who seeks to aid the animal can occur if the rescue is not performed in an organized, efficient and safe manner. Wisconsin Large Animal Emergency Response Inc. (WLAER) exists to reduce the number of injuries and deaths associated with the handling of large animals during emergencies while increasing the safety and efficiency of first responders and veterinarians by creating response teams and implementing training programs.
